International Repairs: ITAR and EAR Controlled Shipments to MHD-ROCKLAND

Commodities originating from Countries that are proscribed within the U.S. Department of State ITAR's Country Policies and Embargoes list, 22 CFR 126.1, and/or prohibited under part 746 of the U.S. Department of Commerce Export Administration Regulations will not be accepted by MHD-ROCKLAND without a license or other US government approval.

When your material has been sent please provide the following documents to your point of contact at MHDR to ensure no delays occur.

- Commercial Invoice
- Purchase Order
- Shippers Declaration of US Goods Returned
- Shipment Airway Bill of Lading number, or, the Ocean Bill of Lading number.

Please provide the shipment Airway Bill of Lading number, or, the Ocean Bill of Lading number.

For all importations of defense articles (of US-origin) for repair, please include the following statement on the Commercial Invoice and the Bill of Lading:

'This shipment is being imported in accordance with, and under, the authority of 22 CFR 123.4(a)(1). and/or provisions of the U.S. Department of Commerce EAR's Imported for repair and re-export

It is the responsibility of the customer to identify and mark and consign each shipment to MHDR as indicated above. Failure to do so will place full responsibility on the customer. Additionally, failure to comply will entitle MHDR to recover from the customer any costs incurred.

After the component has been serviced, it will be exported back to you under the respective exemption or exception

Customer furnished material:

For all customer furnished parts provided for inclusion into a repair undertaken by MHD-ROCKLAND. Please identify on the paperwork the corresponding MHD-ROCKLAND Work order this material is for.
